11. That the school shall submit the return to the Act branch of the Directorate of Education as per rule 180 (1) of the DSEA & Rule 1973 annually.
12. That the facilities prescribed under 50 & 51 of the DSEA & Rule 1973 shall be made available to the students.
13. Proof of the effect that qualified staff shall be appointed as per RRs be provided for verification by the E.O.
14. That the staff shall be paid all arrears and shall be paid as per 5th pay commission. Proof shall be given to E.O. for verification.
15. That the arrangements for good drinking water shall be made available to all the students as well as to the teachers and sanitary facilities shall be provided to the students adequately.
16. The school shall have the medium of instruction as per Rule 6,7 and 8 of DSEA & Rule 1973
17. Provident Fund register shall be maintained and cashbook shall be completed and shown to E.O. of the Zone concerned for verification from time to time.
18. That the violation of any instruction/ condition/ rules and regulations of the department shall lead to action against the school as per section 24 of the DSEAR 1973.
19. That the school shall equip the Science lab as per norms of the department and suitable facilities for practical work shall be provided to the students.
20. That the management of the school create a Reserve fund as per norms.
21. All the conditions of recognition under section 4 of the Act will continue to be complied with.
22. The school authority would admit the students in such manner that each and every child gets at least 10 Sq.Ft. area
23. That the school grant minimum 20% freeship (which include T.F., P.T.A. of any other fees/ funds/ charges of any kind related to teaching - learning) to the children of the weaker section of that society w.e.f Academic session 2007 - 2008.
24. That the recognition granted is subject to fulfillment of conditions of affiliation of CBSE and the school should not start Secondary / Sr. Secondary classes without grant of affiliation by the Board concerned.
